## Race Training Lane Policy

1. Training lanes are offered on an **'as available'** basis.
2. Minimum seven-day advance booking required.
3. In advance of training, each groups/organization must provide a copy of its liability insurance policy, with a rider showing Boyne USA, Inc. named as additional insured.
4. In advance of training, each group/organization must provide executed individual liability waivers, signed by each participant, including coaches (parent or guardian for minors younger than 18). See page 2 of this document for individual waiver.
5. Resort reserves the right to cancel scheduled training if conditions warrant. In marginal weather, please reconfirm prior to traveling.
6. Groups may, in some cases, use resort-provided fencing, signs, and start house facilities if arranged in advance. Contact Mark Skop to make arrangements.
7. Groups will provide their own gates and other training aids.
8. Groups assigned to an 8:30 a.m. lane will use **ONLY** their designated training lane FOR ALL SKIING until after 9:00 a.m.
9. Use of SnowSports Academy line at lifts is not permitted.
10. Groups will remove all gates and equipment, and smooth out ruts and berms immediately following each session.

**SPECIAL EVENT RELEASE**

**ACKNOWLEDGEMENT AND ASSUMPTION OF RISK AND WAIVER AND RELEASE FROM LIABILITY**

I \_\_\_\_\_, know that Alpine, Nordic, Freestyle and Slopestyle Skiing and Snowboarding are action sports carrying significant risk of serious personal injury, death or property damage. I acknowledge that ski racing, performing aerial maneuvers and various tricks such as may be performed at this special event significantly enhance and increase all of these risks. Becoming inverted during an aerial maneuver, whether intentionally or accidentally, substantially increases the risk of serious injury. I also know that there are natural, mechanical and environmental conditions and risks, whether on a racecourse, in a half pipe or terrain park, which independently or in combination with my activities may cause property damage, or severe or even fatal injuries to me or others. I agree that I alone am responsible for: (a) my safety while participating in this special even and/or training for this special event and (b) providing, utilizing and maintaining that equipment necessary for the safe enjoyment of my participation in this special event and specifically acknowledge that BOYNE USA, \_\_\_\_\_ (insert names of all event sponsors) the ski area, the ski school, Boyne Country Sports, BVBCS LLC and their employees, and any agents, representatives, officers, directors, employees, members or affiliates of any person or entity associated with them are not responsible for my safety. I specifically RELEASE and DISCHARGE in advance, those parties from any liability whether known or unknown, even that liability which may arise out of negligence or carelessness on the part of persons or entities mentioned above. I agree to accept all responsibility for the risks, conditions and hazards which may occur whether they now be known or unknown.

I understand that an appropriate helmet may be required for my participation in this special event and I understand that mandatory helmet usage is in no way intended to inspire false confidence and replace the necessity of common sense and safety. The use of a helmet does not eliminate potential injury. The parties covered by this Agreement do not assume any responsibility or duties to me by requiring the use of a helmet. It is my sole responsibility to select an appropriate helmet for accident protection.

Being fully aware of the risks, conditions and hazards of the proposed activity as a participant, I HEREBY AGREE TO WAIVE, RELEASE AND DISCHARGE any and all claims for damages for death, personal injury or property damage which I may have or which may hereafter accrue to me as a result of any participation in this special event or training for this special event, against any person or entity identified above whether such injury or damage was foreseeable or not, including any such claims regarding design of slopes, racecourse, half pipe or any features which may be contained in a terrain park (natural or manmade) or the proximity of any hazard outside the event area to the event area or maintenance or the design or condition of any equipment utilized by me in such special event without regard to whether such equipment is specified or recommended by the persons or entities identified above.

I further agree to forever HOLD HARMLESS and INDEMNIFY all persons and entities identified above, generally and specifically, from any and all liability for death, personal injury or property damage, resulting in any way from my participating in this special event or training for this special event.

I have been given an opportunity to inspect the course or venue and agree by my participation to accept the conditions as they exist. I agree that I will accept and abide by the rules and regulations of BOYNE USA and any other rules or regulations imposed by the organizers of this special event. This Acknowledgement & Assumption of Risk and Waiver & Release from Liability shall be binding upon my heirs and assigns.
